Official statistics underestimate the value of women's work and their overall contribution to wealth.

Women represent a substantial proportion of the agricultural workforce.

Women's work is not compensated equitably.

Women continue to provide a large portion of the agricultural labor in product supply chains.

Many women become heads of household due to migration, armed conflicts, others reasons

WOMEN IN AGRICULTURE

It is estimated that women represent around 43 % of the agricultural workforce globally, especially in the lower class in the rural sector (FAO, 2011).

However.

- In some Latin American countries, it is found that more than 90% of agricultural land titles belong to men (STM-COMMCA, 2021).
- Less than 18% of rural women in the region (Central America- Dom. Republic) receive their own income (STM-COMMCA, 2021).





- Despite the important _ contribution of women to agriculture , they face challenges as :
 - lack of access to resources and technologies _ suitable
 - gender discrimination _ _
 - the limited participation in decision making in the agricultural sector

Women are coming together to affirm their significance in driving sectoral development.

MAYACERT has created a code focused on reflecting on this historical, cultural and social reality.

The code promotes the creation of productive systems based on "Gender Equality."

Aims to make visible the efforts of women in different sectors, historically dominated by men.



CMM Certification

It began with the interest of ACODIHUE (Huehuetenango Integral Development Cooperation Association) together with MAYACERT and the support of HIVOS; specifically for the first pilot of the Code, for coffee cultivation (2006).


CERTIFICATION CODE THAT SEEKS TO PROMOTE THE IMPROVEMENT OF QUALITY CONDITIONS IN THE PRODUCTION AND PREPARATION OF PRODUCTS MADE BY WOMEN.

IMPROVE RELATIONSHIPS AND CONDITIONS FOR ALL THOSE WHO ARE PART OF THE SUPPLY CHAIN OF AGRICULTURAL PRODUCTS - COFFEE, LIVESTOCK, ARTISANAL PRODUCTS, AND OTHERS, PRODUCED BY WOMEN.



Code Objectives

- ▶That all women, with or without a farm, with or without property title, wives or heads of household, who contribute to the economy, are finally included and considered as producers, with the respect and dignity they deserve.
- Create productive systems based on "Gender Equity".
- ▶ Provide new alternatives to improve quality conditions in the social, economic, quality of production and environmental areas for all people involved in the supply chain .



Code bases


That the women are part of the program:

- ► can access to decent work and life conditions for, their families, employees and collaborators.
- have economic viability through fair wages.
- Develop a traceability system for the product(s), through which they can separate and differentiate the certified product from the non- certified product.
- ► Have the tools to manage their products

Certification protocol _

Quality principle

- •Quality in management, Generate a transparent internal system.
- •Aspects that guarantee that a quality product is obtained.
 - –Resistant varieties (crops)
 - -Safety when collecting the product
 - -Etc.







Social responsibility principle

Seeks to ensure a safe environment labor, based on gender equality

Environmental Responsibility Principle

Economic Responsibility Principle

- ► Ensure that the supply chain (from producers to exporters) have a transparent process and origin (traceability).
- ► Guarantee fair remuneration for producers and workers

CERTIFICATION PROCESS

Process steps



Step 1: Application for certification (application form, self-assessment form, list of producers, in case of groups)

Step 2: Quotation



Step 3: Conclusion of the contract

Step 5: Field Audit and NC Delivery



Step 6: Preparation of inspection report



Step 7: Root Cause Analysis and NC Shutdown



Step 8: Review of reports and certification decision



Step 9: Issuance of the certificate



How does CMM Work?


The organization must:

- ► Have an Internal Control System (when applicable).
- ▶ Implement practices according to the stipulated by the code .
- ► Carry out internal inspections and self-assessment and an external inspection annually, this last is carried out by the certifier .
- ► Continuous improvement .

MULTI GROUP CERTIFICATION.

Critical points

100% female producers, owners or administrators

Clear identification of a person (woman) or committee in charge of implementing the standard

Prohibition of child labor, forced labor, abuse at work or discrimination.

There is a policy that describes the organization's commitment to the implementation of the requirements of the Con Manos de Mujer seal.

There is fair payment, and it is paid directly to the female workers, not to men who represent them.

The entity demonstrates a commitment to continuous improvement and participates in the improvement process.

100% of the product collected belongs to female members (applicable for groups)




System CMM Code Qualification


Each indicator has been assigned a specific value, the sum of the points obtained is expressed as a percentage of compliance, which is also related to the colors:


- 0 = Red (Unacceptable Applies for continuous improvement)
- 1 = Yellow (Basic- Applies for Continuous Improvement)
- 2 = Orange (Good Qualifies for a certificate)
- 3 = Light Green (Advanced qualifies for a certificate)
- 4 = Dark Green (Excellent qualifies for a certificate)

By obtaining a grade greater than or equal to 50% You can apply for certification.

Continuous improvement is required to remain in the program.
